

## **End User License Agreement for Organizer for Outlook**

END-USER LICENSE AGREEMENT FOR Ceptara (R) Software applications IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL.

Ceptara Corp.'s ("Company") End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and the Company for the Company's software product(s) identified above which may include associated software components, media, printed materials, and online materials or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and Ceptara Corp., (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. 1. GRANT OF LICENSE.

The SOFTWARE PRODUCT is licensed as follows:

(a) Installation and Use.

Licenser grants you the right to install and use copies of the SOFTWARE PRODUCT on your computer(s) (up to 5 computers) running a validly licensed copy of the operating system for which the SOFTWARE PRODUCT was designed [e.g., Windows 95, Windows NT, Windows 98, Windows 2000, Windows 2003, Windows XP, Windows ME, Windows Vista, Windows 7 or Windows 8x].

(b) Backup Copies.

You may also make copies of the SOFTWARE PRODUCT as may be necessary for backup and archival purposes.

- 2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.
- (a) Maintenance of Copyright Notices. You must not remove or alter any copyright notices on any and all copies of the SOFTWARE PRODUCT.
- (b) Distribution. You may not distribute registered or evaluation copies of the SOFTWARE PRODUCT to third parties.

Evaluation ("Free") copies collect information about the tools use, such as, session parameters, database storage characteristics, feature usage, error logs and other anonymous behaviorial information, none of which uniquely identify the user. Production ("Not Free") copies have the ability to collect same information, do not so by default, and provide mechanisms for the user to opt-in. All information collected follows Ceptara's privacy policy [1].

#### 3. TERMINATION

Without prejudice to any other rights, Company may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT in your possession.

This EULA grants you no rights to use such content. All rights not expressly granted are reserved by Company.
